Agenda Item #6- Consider and Approve a Proposal for the 2024 Ad Valorem Tax Rate and

Scheduling of the Public Meeting to Vote on the 2024 Tax Rate

The Board of Regents annually proposes a tax rate for the upcoming year for the Ranger College

taxing district. The following information includes the applicable tax rates per \$100 of appraised

value as provided by the Eastland County Appraisal District:

2023 Adopted Tax Rate-M&O \$0.014764

2023 Adopted Tax Rate- I&S \$0.271369

2023 Adopted Tax Rate- \$0.286133

2024 No-New-Revenue Tax Rate- \$0.272607

2024 Voter-Approval Tax Rate- \$0.257029

2024 Debt I&S Tax Rate- \$0.241552

2024 No-New-Revenue M&O Tax Rate- \$0.014331

2024 Voter-Approval M&O Tax Rate-\$0.015477

The no-new-revenue calculation is reporting an increase in rate from the previous year and the

voter approval tax rate calculation is reporting a decrease in rate from the previous year. If the Board

of Regents proposes a tax rate that exceeds the no-new-revenue tax rate but does not exceed the

voter approval tax rate, a public hearing is required on the proposed tax rate prior to adoption the

tax rate. Notice of the public hearing, if necessary, must be made seven days prior to the public hearing.

As required by law, the Notice of Tax Rates and the Tax Rate Calculation worksheet were posted on our website on July 24, 2024.

The proposed tax is necessary to fund debt service costs from the General Obligations bonds authorized by district voters on November 8, 2016, as well as facility and operating costs for the 2024 tax year.

Regent Crawley made and Regent Herod seconded a motion to approve to set the 2024 proposed tax rate at the voter-approval tax rate of \$0.257029per \$100 of taxable value and schedule the public meeting to vote on the proposed tax rate on August 26, 2024, at 6:00 pm in the Goleman Library Board Room. The motion was carried unanimously. All members were present at the meeting.

Regent Herod made and Regent Dains seconded a motion to approve the renewal of grant employees as presented by administration. The motion was carried unanimously.
